4. FIRST AID MEASURES

5. FIRE FIGHTING MEASURES

10. STABILITY AND REACTIVITY

11. TOXICOLOGICAL INFORMATION

INGESTION: Corrosive. May cause burning of the mouth, throat and stomach. Ingestion may cause coughing, constriction of the throat due to swelling of the larynx and vomiting blood or blood in diarrhoea. Breathing difficulties, shock and convulsions may follow.
